- a. <u>Eagle Landing Update</u>-Jeremy Erling informed the Board that North Charleston Housing Authority and Brinshore Development is currently pursuing applying for the 9% Tax Credit Application with SC Housing. The deadline to apply is February 15, 2025.
- b. <u>Horizon Village Update</u>-Jeremy discussed a cost estimate for repairing the units at Horizon Village. Commissioner Baxter made a motion to authorize North Charleston Housing Authority to allocate \$1,200,000 for repairing the units at Horizon Village and for North Charleston Housing Authority to issue an RFQ to hire an Owner's Representative and requiring the Owner's Representative to report back to North Charleston Housing Authority when they reach \$200,000.00. This will allow the Board to pause work or adjust the budget if necessary. Motion seconded by Commissioner Thrower.
